Explanation of Responses:

1. On 4/7/22, the Reporting Person was granted 1,059,322 Restricted Stock Units ("RSUs"), vesting in four equal installments on the first, second, third and fourth anniversaries of 4/1/22. Accordingly, 264,830 RSUs vested on 4/1/23 and were settled effective as of 4/7/23 (64,486 of which were withheld by the issuer to cover the required withholding taxes of RSUs). RSUs convert into common stock on a one-for-one basis.
